

RESOLUTION NO. 2015-141

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE DISPENSING WITH A COMPETITIVE PROPOSAL PROCESS AND AUTHORIZING THE CITY MANAGER TO EXECUTE A FIRST AMENDMENT TO CONTRACT #C-11-392 WITH LAW ENFORCEMENT CHAPLAINCY OF SACRAMENTO FOR CHAPLAINCY SERVICES IN THE AMOUNT OF \$40,000 FOR A TOTAL CONTRACT NOT-TO-EXCEED AMOUNT OF \$80,000

WHEREAS, law enforcement personnel face difficult, life-threatening events as part of their job; and

WHEREAS, members of the community may, at times face serious, life-altering events; and

WHEREAS, Law Enforcement Chaplaincy of Sacramento has been a trusted partner, providing chaplaincy services to the City of Elk Grove for many years; and

WHEREAS, law enforcement chaplaincy is a unique service and is only offered in the Sacramento region by Law Enforcement Chaplaincy of Sacramento; and

WHEREAS, it is in the best interest of the City to proceed with securing an agreement with Law Enforcement Chaplaincy of Sacramento and dispense with the competitive proposal process as allowed by City of Elk Grove Municipal Code section 3.42.140(B)(2).

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove dispenses with a competitive proposal process and authorizes the City Manager to execute a First Amendment to contract #C11-392 with Law Enforcement Chaplaincy of Sacramento for chaplaincy services in the amount \$40,000 for a total contract not-to-exceed amount of \$80,000.


