

RESOLUTION NO. 2015-150

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT WITH
PROFESSIONAL DEVELOPMENT INSTITUTE FOR A POLICE DEPARTMENT
STAFFING STUDY IN AN AMOUNT NOT TO EXCEED \$70,000**

WHEREAS, the Elk Grove Police Department was established in 2006 when the City Council voted to end the City's contract for police services with the Sacramento County Sheriff's Department; and

WHEREAS, in 2006, the City set forth a vision for creating a first class Police Department dedicated to the philosophy of Community Policing; and

WHEREAS, Community Policing is defined as a law enforcement agency's commitment to promote organizational strategies that support the systematic use of partnerships and problem-solving techniques to proactively address the immediate conditions that give rise to public safety issues such as crime, social disorder and fear of crime; and


WHEREAS, the City has experienced significant growth and change since 2006 necessitating an evaluation of police staffing resources versus service level demands, including expectations of quality of service; and

WHEREAS, the Police Department advertised an RFP for a Police Department Staffing Study for five weeks, and received seven proposals from qualified firms; and

WHEREAS, after review and scoring of proposals received, an evaluation team found Professional Development Institute to be the most qualified firm to provide the City with a Police Department Staffing Study.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute an agreement with Professional Development Institute for a Police Department Staffing Study in an amount not to exceed \$70,000.


