

RESOLUTION NO. 2015-195

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
ACCEPTING THE CITY HALL ADA IMPROVEMENTS AND ELECTRIC VEHICLE
CHARGING STATION INSTALL PROJECTS (WFM007/WFM006) AS COMPLETE;
AND AUTHORIZING THE CITY ENGINEER TO PREPARE AND THE CITY CLERK TO
FILE THE NOTICE OF COMPLETION WITH THE SACRAMENTO COUNTY
RECORDER**

WHEREAS, on September 10, 2014 the City Council authorized the award of a construction contract to Franzoia Construction for the City Hall ADA Improvements and Electric Vehicle Charging Station Install Projects (Capital Improvement Project ID WFM007/WFM006) (the "Project"); and

WHEREAS, the Projects constructed and modified pedestrian ramps work to comply the Americans with Disabilities ACT (ADA) and installed an Electric Vehicle Charging Station in the City Hall front parking lot; and

WHEREAS, Franzoia Construction has completed the physical construction work in accordance with the terms and conditions of the contract documents for the Project; and


WHEREAS, Franzoia Construction has not submitted all contractually required labor compliance documentation, in violation of the terms and conditions of the contract documents for the Project, and potentially in violation of state law; and

WHEREAS, the State of California Department of Industrial Relations (DIR) is investigating these violations and has requested the City file a Notice of Completion for the project and withhold all remaining monies potentially due to Franzoia Construction until the DIR's investigation and any penalty assessment is completed.


NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby accepts the City Hall ADA Improvements and Electric Vehicle Charging Station Install Projects as complete; and

BE IT FURTHER RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Engineer to prepare a Notice of Completion and the City Clerk to file the Notice of Completion for the Project with the Sacramento County Recorder.


