A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT FOR PROFESSIONAL ENGINEERING SERVICES ASSOCIATED WITH THE SHELDON ROAD AND BRADSHAW ROAD BRIDGE REPLACEMENT AND INTERSECTION IMPROVEMENT PROJECT (PT0137) FOR A TERM OF FIVE YEARS IN AN AMOUNT NOT TO EXCEED \$731,284.89, WITH DRAKE HAGLAN & ASSOCIATES

WHEREAS, the City of Elk Grove, Department of Public Works, applied for and was awarded Federal funds to augment local funds for the delivery of the Project; and

WHEREAS, the Project is included in the approved Fiscal Year 2015-16 Budget; and

WHEREAS, Public Works implemented a formal selection process in accordance with City, State, and federal law and has determined that Drake Haglan & Associates was determined to be the most qualified firm; and

WHEREAS, Public Works has negotiated a Professional Services Agreement (Contract) with Drake Haglan & Associates to provide the required services; and

**WHEREAS**, the term of the Contract will be for five (5) years.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute the Contract in an amount not to exceed \$731,284.89 for Professional Engineering Services with Drake Haglan & Associates.
