

RESOLUTION NO. 2016-167

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
ACCEPTING THE ELK GROVE-FLORIN AT WEST CAMDEN SIDEWALK INFILL
PROJECT (WAC009) AS COMPLETE; AND AUTHORIZING THE CITY ENGINEER TO
PREPARE AND THE CITY CLERK TO FILE THE NOTICE OF COMPLETION WITH
THE SACRAMENTO COUNTY RECORDER**

WHEREAS, on March 9, 2016, the City Council authorized the award of a construction contract to All-American Construction, Inc. for the Elk Grove-Florin Road at West Camden Sidewalk Infill Project (WAC009); and

WHEREAS, the Project closed a gap of discontinuous sidewalk along Elk Grove-Florin Road. Improvements included installation of sidewalk, curb, gutter, drain inlet, pipes, pavement widening, and sign removal and replacement. The Project also constructed two curb ramps, crosswalk striping, and signage along West Camden Drive near South Camden Way; and

WHEREAS, All-American Construction, Inc. has completed the work in accordance with the terms and conditions of the contract documents for the Project; and

WHEREAS, if no liens or claims have been filed within thirty-five (35) days of filing the Notice of Completion, the retained payment funds and any remaining amount due will be released to All-American Construction, Inc.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby accepts the Elk Grove-Florin Road at West Camden Sidewalk Infill Project (WAC009) as complete; and

BE IT FURTHER RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Engineer to prepare a Notice of Completion and the City Clerk to file the Notice of Completion for the Project with the Sacramento County Recorder.




