

RESOLUTION NO. 2016-190

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY ENGINEER TO REJECT ALL BIDS RECEIVED FOR THE
RURAL ROADS SHOULDER BACKING SAFETY IMPROVEMENT PROJECT
(WRM001); DIRECTING THE CITY ENGINEER TO RE-BID THE PROJECT; AND
AMENDING THE 2016-17 BUDGET AND 2016-21 CAPITAL IMPROVEMENT
PROGRAM FOR THIS PROJECT TO ADD \$221,000 OF GAS TAX**

WHEREAS, the Rural Roads Shoulder Backing Safety Improvement Project (WRM001) will raise and flatten shoulders by placing shoulder backing on Grant Line Road, Bradshaw Road, Kammerer Road, and Waterman Road (Work);

WHEREAS, the Project is included in the approved Fiscal Year 2015-20 Capital Improvement Program and is budgeted with funds in the approved Fiscal Year 2016-17 Budget; and

WHEREAS, an invitation to bid was duly advertised on August 5, 2016 and August 12, and bids were opened on September 1, 2016; and


WHEREAS, two qualified bids were received from Martin Brothers Construction and Delta Construction Company that significantly exceed the Project budget; and

WHEREAS, the Project needs additional funds to bid and construct the Project in the amount of \$221,000 from available Gas Tax funds balance.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby:

- 1) Authorizes the City Engineer to reject all bids received for the Rural Roads Shoulder Backing Safety Improvement Project (WRM001); and
- 2) Directs the City Engineer to re-bid the Project.
- 3) Amends the 2016-17 Budget and 2016-21 Capital Improvement Program for the Rural Roads Shoulder Backing Project (WRM001) by adding \$221,000 of Gas Tax Funds to the Project.




