

**RESOLUTION NO. 2016-195**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER TO EXECUTE AN AMENDMENT TO THE CONTRACT WITH HF&H CONSULTANTS, LLC (CONTRACT NO. C-16-244) FOR PROVIDING ASSISTANCE DURING NEGOTIATIONS WITH REPUBLIC SERVICES FOR A NEW RESIDENTIAL SOLID WASTE COLLECTION FRANCHISE AGREEMENT TO INCLUDE ADDITIONAL TASKS AND INCREASE THE TOTAL BUDGET BY \$82,049.00 [FOR A TOTAL AMOUNT NOT-TO-EXCEED \$132,044.00]**

**WHEREAS**, in June 2016, the City of Elk Grove solicited informal quotes from four (4) firms to provide negotiation assistance for a new residential solid waste collection franchise agreement with Republic Services; and

**WHEREAS**, a total of two responses were received, and HF&H Consultants, LLC was found to have the most responsive proposal; and

**WHEREAS**, following the initial phases of negotiations, the City identified additional tasks needed that would require the assistance of a consultant; and

**WHEREAS**, HF&H, having already been involved with those negotiations, possesses the ability to complete those tasks in a timely and efficient manner; and

**WHEREAS**, for the reasons presented, it is not in the best interest of the City to pursue further solicitation of competitive proposals for these additional services.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby dispenses with solicitation of further competitive proposals for the services described herein and authorizes the City Manager to execute a contract amendment, adding additional tasks and increasing the budget of the existing contract (C-16-244) with HF&H Consultants, LLC by \$82,049.00 [for a total budget not to exceed \$132,044.00].
