

RESOLUTION NO. 2016-212

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE A THREE YEAR CONTRACT
WITH AN OPTIONAL TWO YEAR EXTENSION WITH THE SIGN CENTER OF ELK
GROVE FOR VEHICLE GRAPHIC SERVICES FOR CITY OWNED VEHICLES IN AN
AMOUNT NOT-TO-EXCEED \$75,000**

WHEREAS, the City of Elk Grove's Fleet division maintains City vehicles including mechanical, structural and aesthetic standards; and

WHEREAS, in September of 2016, the City announced a formal Invitation for Bid (IFB) for vehicle graphic services for City owned vehicles; and

WHEREAS, the City received one response to the IFB, The Sign Center of Elk Grove; and

WHEREAS, The Sign Center of Elk Grove met all of the formal bid requirements pursuant to Elk Grove Municipal Code Section 3.42.180(a) and therefore was found to be the lowest responsive responsible bidder; and

WHEREAS, Fleet Services has sufficient funding identified in its 2016-17 operating budget for this service.

NOW, THEREFORE BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a three-year contract in substantially the form presented to the City Council with The Sign Center of Elk Grove with one additional two-year extension in an amount not-to- exceed \$75,000 for vehicle graphics for City owned vehicles.


