

RESOLUTION NO. 2016-222

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE DISPENSING WITH COMPETITIVE BIDDING PURSUANT TO ELK GROVE MUNICIPAL CODE CHAPTER 3.42 AND AUTHORIZING THE CITY MANAGER TO EXECUTE AMENDMENT 6 TO CONTRACT C-08-242 WITH CORDICO PSYCHOLOGICAL CORPORATION FOR PRE- AND POST-EMPLOYMENT SERVICES INCREASING THE TOTAL CONTRACT NOT-TO-EXCEED AMOUNT TO \$100,000 AND EXTENDING THE TERM FOR AN ADDITIONAL THREE YEARS

WHEREAS, law enforcement is a high-stress, often dangerous job that requires persons with mental and emotional stability to successfully perform under such conditions; and

WHEREAS, psychological evaluations are an important component in the decision-making process for hiring police officers; and


WHEREAS, professional psychological evaluations are critical to establishing fitness for duty of potential new hires; and

WHEREAS, staff conducted a search and found that Cordico Psychological Corporation is the only provider of law enforcement pre- and post-employment psychological services in the Sacramento area; and

WHEREAS, pursuant to Elk Grove Municipal Code Sections 3.42.140(B)(3), the City Manager may dispense with the competitive bidding process when, in the judgment of the City Manager or City Council, compliance with the procedure is not in the best interest of the City.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove finds that a competitive bid process is not in the best interest of the City, hereby dispenses with competitive bidding, and authorizes the City Manager to execute Amendment 6 to Contract C-08-242 with Cordico Psychological Corporation for pre- and post-employment services increasing the total contract not-to-exceed amount to \$100,000 and extending the term for an additional three (3) years.




