

RESOLUTION NO. 2016-235

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE A CONSULTANT SERVICES
CONTRACT WITH HF&H CONSULTANTS, LLC, FOR ASSESSMENT AND LONG-
RANGE STRATEGIC PLANNING SERVICES FOR WASTE REDUCTION AND
RECYCLING IN AN AMOUNT NOT-TO-EXCEED \$102,070**

WHEREAS, in August 2016, the City of Elk Grove posted a formal Request for Proposals for consultant services to create a long-range strategic plan for waste reduction and recycling and to complete an analysis of the City's waste and recycling needs and objectives; and

WHEREAS, the City received three submittals, and a review committee made up of five public agency representatives reviewed and scored proposals; and

WHEREAS, following the review and scoring, it was determined that HF&H Consultants, LLC offered the most responsive proposal and has met all of the criteria in the request for proposals; and

WHEREAS, the Solid Waste Transfer Station Enterprise Fund (506) has sufficient funding for these services.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a contract in substantially the form presented to the City Council with HF&H Consultants, LLC, for assessment and long-range strategic planning services for waste reduction and recycling in an amount not-to-exceed \$102,070.
