RESOLUTION NO. 2017-017

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING CHANGES TO SUPPORT PROVIDED TO THE CITY COUNCIL

WHEREAS, the City Council of the City of Elk Grove wishes to reclassify the Assistant to the Mayor position to an Administrative Assistant to the City Council to support the Mayor and four (4) Council Members; and

WHEREAS, the City Council of the City of Elk Grove would like to re-allocate the \$50,000 budget currently budgeted for part-time administrative support for the four (4) Council districts to be shared equally between the Mayor's office and all Council districts; and

WHEREAS, the City Council of the City of Elk Grove wishes to change the number of part-time Council Assistants from four (4) to five (5) in the event that the funds are used for additional administrative support.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to reclassify the Assistant to the Mayor position to an Administrative Assistant to the City Council.

NOW, THEREFORE, BE IT FURTHER RESOLVED that the City Council of the City of Elk Grove hereby adds one (1) part-time Council Assistant by increasing the number of Assistants from four (4) to five (5) with no increase to the total budget for Council Assistant, providing the Mayor's office and each Council Member with a discretionary budget of \$10,000 per fiscal year for the needs of their office. Council Assistants shall be paid \$12 per hour, or minimum wage, as provided by applicable law, whichever is greater, all subject to a future vote of the City Council that effectively raises the hourly rate of Council Assistants, all consistent with applicable law.

NOW, THEREFORE, BE IT FURTHER RESOLVED that these changes are made as shown below:
