

RESOLUTION NO. 2017-135

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE THE SECOND AMENDMENT
TO CONTRACT #C-12-299 WITH SUTTER MEDICAL FOUNDATION FOR POLICE
MEDICAL EVIDENTIARY EXAMINATION SERVICES INCREASING THE CONTRACT
NOT-TO-EXCEED AMOUNT FROM \$150,000 TO \$300,000**

WHEREAS, evidentiary examinations are critical to the investigation of sexual assaults; and

WHEREAS, law enforcement and medical service providers recognize the benefit to survivors and society of the thorough investigation and successful prosecution of the sexual offender; and

WHEREAS, there must exist a formal agreement between law enforcement and medical providers as to how each will perform its role in the investigatory process of a sexual assault; and

WHEREAS, Sutter Medical Foundation has provided reliable law enforcement medical evidentiary exams for the Elk Grove Police Department for over ten (10) years; and

WHEREAS, Sutter possesses the requisite training and certification necessary for evidentiary and laboratory examination to be used in a court of law; and

WHEREAS, this amendment increases the total contract amount from \$150,000 to \$300,000; and

WHEREAS, this service is included in the Police Department's annual operating budget submission, and there is currently sufficient funding to continue this service.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute the second amendment to contract #C-12-299 with Sutter Medical Foundation for police medical evidentiary examination services, in substantially the form presented, increasing the contract not-to-exceed amount from \$150,000 to \$300,000.


