## **RESOLUTION NO. 2018-097**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE DISPENSING WITH THE FORMAL SOLICITATION PROCEDURE PER ELK GROVE MUNICIPAL CODE SECTION 3.42.188(B)(3) AND AUTHORIZING THE CITY MANAGER TO EXECUTE A MEMORANDUNI OF UNDERSTANDING BETWEEN THE CITY OF ELK GROVE, THE COUNTY OF SACRAMENTO AND THE CITIES OF CITRUS HEIGHTS, FOLSOM, GALT, RANCHO CORDOVA, AND SACRAMENTO FOR THE PURCHASE AND MAINTENANCE OF A SHARED EMERGENCY OPERATIONS SOFTWARE SYSTEM

WHEREAS, the Elk Grove Police Department was successful in establishing an Emergency Operations Center (EOC), including purchasing EOC equipment and technology, using grant funding from the Department of Homeland Security Appropriations Act; and

WHEREAS, in 2012 the Sacramente County Office of Emergency Services convened a group of representatives from the region to select emergency operations software that would meet the needs of each agency and provide interoperability between the agencies; and

WHEREAS, interoperability is crucial to managing an EOC; and

WHEREAS, the ability to communicate with agencies within the region is necessary to mobilizing all of the appropriate resources available and preserving the safety of residents; and

WHEREAS, multiple agencies using the same EOC software increases interagency communication, which is critical to success in addressing an interagency emergency; and

WHEREAS, Web-EOC from Intermedix was chosen as the best software to serve the multiple agencies' needs and has been in use since 2012; and

WHEREAS, for the reasons presented, pursuit of a competitive proposal process for the subject services is not in the best interest of the City; and

WHEREAS, to ensure interoperability between agencies in the region, the City of Elk Grove, Sacramento County, and the cities of Citrus Heights; Folsom, Galt, Rancho Cordova, and Sacramento desire to enter into a Memorandum of Understanding that will purchase and maintain EOC software to be used by the respective partners.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby dispenses with the formal solicitation procedure per Elk Grove Municipal Code section 3.42.188(B)(3) and authorizes the City Manager to execute a Memorandum of Understanding between the City of Elk Grove, County of Sacramento, and the cities of Citrus Heights, Folsom, Galt, Rancho Cordova, and Sacramento, in substantially the form presented, for the purchase and maintenance of a shared emergency operations software system.
