

RESOLUTION NO. 2018-118

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER TO EXECUTE A CONSTRUCTION CONTRACT WITH AMERICAN PAVEMENT SYSTEMS, INC. FOR THE PAVEMENT RESURFACING 2018 PROJECT (WPR018) IN THE AMOUNT OF \$636,640; AUTHORIZING THE CITY ENGINEER TO APPROVE CHANGE ORDERS NOT-TO-EXCEED \$95,000; AND AUTHORIZING THE CITY MANAGER TO EXECUTE A CONSTRUCTION CONTRACT WITH THE SECOND LOWEST RESPONSIVE BIDDER IF THE FIRST LOWEST RESPONSIVE BIDDER DOES NOT MEET FILING OBLIGATIONS (CEQA EXEMPT)

WHEREAS, the Pavement Resurfacing 2018 Project (WPR018) (Project) includes placing slurry seal, micro-surfacing and striping on various streets throughout the City; and

WHEREAS, the Project is included in the approved Fiscal Year 2017-22 Capital Improvement Program and is budgeted with funds in the approved Fiscal Year 2017-18 Budget; and

WHEREAS, the Project is a project under California Environmental Quality Act (Section 21000 et seq. of the Public Resources Code, hereinafter referred to as CEQA) which requires that cities consider the environmental consequences of their actions before approving a project; and

WHEREAS, the Project was previously determined exempt under CEQA Categorical Exemption 15301(c) (Class 1: Existing Facilities) and approved by City Council through Resolution No. 2018-065, and the Notice of Exemption was filed with the Sacramento County Clerk on April 2, 2018; and

WHEREAS, an invitation to bid was duly advertised on March 16, 2018 and March 23, 2018, and bids were opened on May 1, 2018; and

WHEREAS, American Pavement Systems, Inc. was determined to be the responsible bidder submitting the lowest responsive bid; and


WHEREAS, Pavement Coatings Co. was determined to be the responsible bidder submitting the second lowest responsive bid.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby:

- 1) Authorizes the City Manager to execute a construction contract with American Pavement Systems, Inc. for the Pavement Resurfacing 2018 Project (WPR018) in the amount of \$636,640 upon receipt of all required bonds and insurance and the approval of such bonds and insurance by the City Attorney; and,
- 2) Authorizes the City Manager to execute a construction contract with the second lowest responsive bidder, Pavement Coatings Co., in the amount of \$670,510, if American Pavement Systems, Inc., does not meet filing obligations; and,

3) Authorizes the City Engineer to approve change orders not-to-exceed \$95,000.


