

RESOLUTION NO. 2018-210

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT WITH PERFORMANCE AUTOMOTIVE GROUP INC., A CALIFORNIA CORPORATION DBA ELK GROVE FORD, FOR THE PURCHASE OF TWO NEW FORD TRANSIT VANS WITH A MAVRON INC., CAGING SYSTEM FOR ANIMAL CONTROL IN AN AMOUNT NOT-TO-EXCEED \$122,000

WHEREAS, the City of Elk Grove's Fleet division maintains all City vehicles and procures replacements when necessary; and

WHEREAS, the City has added two additional Animal Control Officers; these positions require cargo vans with animal caging systems to meet the Animal Services division's performance goals of responding to priority calls; and

WHEREAS, in August of 2018, the City announced a formal Invitation for Bid (IFB) for two new unused Ford Transit vans with MAVRON, Inc. Animal Control caging systems; and

WHEREAS, Performance Automotive Group Inc., a California corporation dba Elk Grove Ford met all of the requirements of the IFB, and was therefore found to be the lowest responsive and responsible bidder; and

WHEREAS, sufficient funding is identified in the Police Department's Fiscal Year 2018-19 operating budget for this purchase.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a contract with Performance Automotive Group, Inc., a California corporation dba Elk Grove Ford, in substantially the form presented to the City Council to purchase two new Ford Transit vans with MAVRON, Inc., caging system for Animal Control for an amount not-to-exceed \$122,000.




