A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE DELEGATING AUTHORITY TO THE CITY MANAGER TO APPOINT MEMBERS OF THE HOUSING BOARD OF APPEALS AND LOCAL BOARD OF APPEALS

WHEREAS, the City Council of the City of Elk Grove has adopted Ordinance No. 22-2018, amending Chapter 1.11 of the Elk Grove Municipal Code (EGMC) related to appeals; and

WHEREAS, Ordinance No. 22-2018 has declared that the City will utilize a Housing Board of Appeals and a Local Board of Appeals, comprised of three independently contracted impartial hearing officers who are not employees of the City, and who are knowledgeable in the applicable building codes, regulations and ordinances to hear matters related to building occupancy, repair, and demolition; and

WHEREAS, the City Council has determined that the use of boards of appeal as outlined in EGMC Chapter 1.11 is compliant with California Building Code Sections 1.8 and 113; and

WHEREAS, the City Council may delegate appointment authority as may be necessary to ensure the timely and efficient execution of City business.

NOW, THEREFORE, BE IT RESOLVED that the Mayor, with the approval of the City Council of the City of Elk Grove, hereby authorizes the City Manager to appoint members of the Housing Board of Appeals and Local Board of Appeals; such authority shall become effective on the effective date of Ordinance No. 22-2018.
