

**RESOLUTION NO. 2018-244**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT WITH  
CALIFORNIA ELECTRONIC ASSET RECOVERY (CEAR) FOR TRANSPORTATION  
AND DISPOSAL SERVICES FOR ELECTRONIC AND UNIVERSAL WASTE FOR AN  
AMOUNT NOT-TO-EXCEED \$180,000**

**WHEREAS**, the City of Elk Grove's Special Waste Collection Center (SWCC) collects electronic and universal waste (e-waste) items from residents, and has a need to properly dispose of these items pursuant to state and federal guidelines; and


**WHEREAS**, pursuant to Elk Grove Municipal Code 3.42.140(A), the City issued a formal request for proposals (RFP) on June 27, 2018, for transportation and disposal services for e-waste collected at the SWCC; and

**WHEREAS**, California Electronic Asset Recovery, Inc. (CEAR) was the only contractor to submit a proposal in response to the RFP by the due date of August 10, 2018 and is qualified to perform the requested services; and

**WHEREAS**, since the opening of the SWCC in April 2014, CEAR has provided transportation and disposal services for collected e-waste, and has provided consistent and reliable service to the City.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a contract with California Electronic Asset Recovery (CEAR), in substantially the form presented, for Transportation and Disposal Services for Electronic and Universal Waste for a term of three years, with three one-year options to extend in an amount not-to-exceed \$180,000.


