## **RESOLUTION NO. 2019-049**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE DISPENSING WITH THE COMPETITIVE BIDDING PROCESS PURSUANT TO ELK GROVE MUNICIPAL CODE 3.42.180(B)(3) AND AUTHORIZING THE CITY MANAGER TO EXECUTE A SECOND AMENDMENT TO THE CONTRACT WITH GALLS, LLC (CONTRACT #C-17-297) FOR BALLISTIC VESTS FOR AN ADDITIONAL \$197,000 FOR A TOTAL AMOUNT NOT-TO-EXCEED \$270,000 THROUGH JULY 31, 2022

WHEREAS, each sworn and non-sworn field officer of the Elk Grove Police Department is issued a ballistic vest system, which is used to protect field personnel and is worn at all times when on duty; and

WHEREAS, Elk Grove Police Department replaces all ballistic vests for sworn and non-sworn officers as the vests near their five-year warranty expiration date; and

WHEREAS, in 2017, staff conducted a competitive bid process to find a vendor able to provide the ballistic vests at the best cost and within the timeframe outlined in a Request for Proposals (RFP); and

WHEREAS, Galls, LLC offered the most competitive pricing, quality products, and the ability to adhere to timeframes outlined in the RFP; and

WHEREAS, Galls, LLC has agreed to continue offering the same products at the same pricing and terms found in their agreement; and

WHEREAS, for the reasons presented, pursuing a formal competitive bidding process for the ballistic vests addressed by the proposed amended contract is not in the best interest of the City.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby dispenses with the competitive process pursuant to EGMC 3.42.180(B)(3) and authorizes the City Manager to execute a second amendment to contract #C-17-297 with Galls, LLC for ballistic vests for an additional \$197,000 for a total amount not-to-exceed \$270,000.
