**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE USE AGREEMENTS FOR THE
ELK GROVE AQUATICS CENTER WITH THE CONSUMNES* RIVER AQUATICS
CLUB AND ELK GROVE SWIM TEAM BOOSTERS FOR A TERM OF ONE YEAR**

WHEREAS, the Civic Center master plan was approved by the City Council in January 2016 and included the Elk Grove Aquatics Center. The facility began construction in Spring 2017 and will open in May 2019. The Elk Grove Aquatics Center will be the area's largest aquatics facility when it opens with a 50-meter competition pool, a 25-yard instructional pool, and a recreational pool with a lazy river and two 30-foot slides; and

WHEREAS, one of the intended uses for the facility is competitive swimming; the use of the facility by swim teams provides a venue for youth to be active and engaged in sports and helps to off-set operating costs; and

WHEREAS, the Consumnes* River Aquatics Club and the Elk Grove Swim Team Boosters are established local swim teams, the teams have been committed partners throughout the process to design and build the Aquatics Center and craft these use agreement; and

WHEREAS, the use of the Aquatics Center by the teams will support local sports, generate revenue to off-set operating costs, and attract regional visitors to the area during swim meets.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute use agreements for the Elk Grove Aquatics Center with the Consumnes* River Aquatics Club and Elk Grove Swim Team Boosters in substantially the form presented


