

RESOLUTION NO. 2019-098

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE DISPENSING WITH FORMAL BIDDING PROCEDURES FOR THE PURCHASE OF COMMODITIES AND EQUIPMENT PER ELK GROVE MUNICIPAL CODE SECTIONS 3.42.180(B)(3) AND 3.42.180(B)(4); AUTHORIZING THE CITY MANAGER TO EXECUTE CONTRACTS WITH MULTIPLE VENDORS FOR THE PROCUREMENT OF FURNITURE, FIXTURES, AND EQUIPMENT FOR CIVIC CENTER - COMMUNITY & SENIOR CENTER PROJECT (WCC010) IN AN AMOUNT NOT-TO-EXCEED \$675,839; AND AUTHORIZING AN INCREASE IN CHANGE ORDER AUTHORITY FOR THE CIVIC CENTER - COMMUNITY & SENIOR CENTER PROJECT (WCC010) IN THE AMOUNT OF \$195,800

WHEREAS, the Civic Center - Community & Senior Center Project (WCC010) is a City Facility currently under construction and nearing completion; and

WHEREAS, the recommend furniture, fixtures and equipment (FF&E) identified with the accompanying staff report meet the Project's program and criteria; and

WHEREAS, City Manager has limited authority related to purchasing and contracting for FF&E pursuant to Chapter 3.42, Contract and Purchasing of Elk Grove Municipal Code; and

WHEREAS, for the reasons presented, dispensing with competitive bidding is appropriate for the purchase of the FF&E for the Civic Center - Community & Senior Center Project (WCC010) because solicitation of proposals is either not in the best interest of the City (EGMC Section 3.42.180(B)(3)) and/or the purchase is being processed through a cooperative purchasing agreement with another public agency that is substantially consistent with the City's processes (EGMC section 3.42.180(B)(4)); and

WHEREAS, the total collective cost for this FF&E is consistent with the budget presented on December 12, 2018; and

WHEREAS, the procurement and installation of Exterior Signage, Reception Desks for both Community Center and Senior Center of Elk Grove, and Gift Shop Casework is best provided by the construction contractor for the Community Center and Senior Center; and

WHEREAS, the Project is included in the approved Fiscal Year 2018-23 Capital Improvement Program and is budgeted with funds in the approved Fiscal Year 2018-19 Budget.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby:

- 1) Dispenses with formal competitive bidding procedures for the purchase of the above-referenced commodities and equipment pursuant to Elk Grove Municipal Code Section 3.42.180(B)(3) and 3.42.180(B)(4); and
- 2) Authorizes the City Manager to award and execute contracts with multiple vendors, for the purchase of furniture, fixtures and equipment for the Civic

Center - Community & Senior Center Project (WCC010) in an amount not to exceed \$675,839, all subject to approval as to form by the City Attorney; and


- 3) Authorize an increase in change order authority for the Civic Center - Community & Senior Center Project (WCC010) in the amount of \$195,800.




