**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY ENGINEER TO REJECT ALL BIDS RECEIVED FOR THE
CITY HALL BUILDING WATER INFILTRATION PROJECT (FM1803) AND
DIRECTING THE CITY ENGINEER TO RE-BID THE PROJECT**

WHEREAS, the City Hall Building Water Infiltration Project (FM1803) (Project) includes remediation of water leaks occurring at the south entrance and southwest corner of City Hall and new paint on the front entrances of 8380 Laguna Palms Way and 8400 Laguna Palms Way; and,

WHEREAS, an invitation to bid was duly advertised on May 3, 2019, and May 10, 2019, and bids were opened on June 4, 2019; and,

WHEREAS, one bid was received from Bobo Construction, Inc.; and

WHEREAS, Bobo Construction, Inc. was determined to be a responsible bidder; and

WHEREAS, it is in the City's best interest to reject all bids and re-bid the Project; and,

WHEREAS, the Project is included in the approved Fiscal Year 2018-23 Capital Improvement Program and is budgeted with funds in the approved Fiscal Year 2018-19 Budget.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby:

- 1) Authorizes the City Engineer to reject all bids for the Project; and
- 2) Directs the City Engineer to re-bid the Project.
