**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
ADOPTING THE ADOPTION FEE SCHEDULE FOR ELK GROVE ANIMAL SHELTER**

WHEREAS, the City of Elk Grove (the "City") has constructed and intends to operate a facility to shelter lost and abandoned animals beginning July 1, 2019; and

WHEREAS, the City will have need to facilitate the adoption of animals that have no owners or go unclaimed by owners; and

WHEREAS, Elk Grove Municipal Code Section 8.05.090 authorizes the City to charge for animal adoptions; and

WHEREAS, the City does not have a previously established fee schedule for animal adoptions, but the proposed fees are not expected to exceed the City's reasonable cost to provide the animal shelter.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby adopts the Adoption Fee Schedule as shown in Exhibit A.



Senior (person over 65 or animal 7+)	\$0 - \$25
Kitten (under 6 months old)	\$0 - \$75
Puppy (under 1 year old)	\$0 - \$150
Rodents, Fowl	\$0 - \$10
Rabbit	\$0 - \$25
Exotic, equine and livestock	\$0 - \$2000
