**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE MASTER SERVICES
CONTRACTS WITH BENNETT ENGINEERING SERVICES, INC.; DEWBERRY
ENGINEERS, INC.; DOKKEN ENGINEERING; PSOMAS; AND QUINCY
ENGINEERING, INC. FOR ON CALL ARCHITECTURAL/ENGINEERING SERVICES**

WHEREAS, the City Capital Improvement Program Division is comprised of three City staff members – the Capital Program Manager, and two Senior Civil Engineers; and

WHEREAS, the City contracts with Willdan Engineering (Willdan) to provide project management and architectural/engineering services for all projects and studies identified in the City's Capital Improvement Program (CIP); and

WHEREAS, staff has identified that having additional firms available to support the City will provide additional resources for delivery of the CIP projects and studies required by the City; and

WHEREAS, staff has also identified a shortage of qualified engineers and architects that can provide these services and a limitation on the number of qualified engineers and architects that one firm can provide; and

WHEREAS, Public Works used a formal selection process in accordance with City Purchasing Policy and State laws; and

WHEREAS, Public Works prepared a Request for Qualifications (RFQ) for Professional On-Call Project Management and Architectural/Engineering Services; and

WHEREAS, an RFQ was advertised on January 23, 2019, and a total of 26 firms submitted Statements of Qualifications for Architectural/Engineering Services by the February 26, 2019 due date; and

WHEREAS, Public Works has previously executed Professional Services Agreements with Interwest Consulting Group; Kjeldsen Sinnock Neudeck, Inc.; Coastland Civil Engineering, Inc.; and Ponticello Enterprises to provide Project Administration services in response to the On-Call Project Management component of the RFQ; and

WHEREAS, Bennett Engineering Services, Inc.; Dewberry Engineers, Inc.; Dokken Engineering; Psomas; Quincy Engineering, Inc.; and Wood Rodgers were determined to be the most qualified firms for the Architectural/Engineering Services component of the RFQ; and

WHEREAS, Public Works has negotiated Professional Services Agreements with Bennett Engineering Services, Inc.; Dewberry Engineers, Inc.; Dokken Engineering; Psomas; and Quincy Engineering, Inc., to provide Architectural/Engineering services.


NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute master services contracts, in substantially the form presented, for On Call Architectural/Engineering Services with Bennett Engineering Services, Inc.; Dewberry Engineers, Inc.; Dokken Engineering; Psomas; and Quincy Engineering, Inc., for an initial term of three years, with two optional one-year extensions, at the discretion of the City Manager, in amounts not to exceed \$7,000,000 each, and subject to appropriation of funds in each fiscal year budget.
