

RESOLUTION NO. 2021-017

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE ACCEPTING THE 2019-2020 CITYWIDE CURB RAMP IMPROVEMENTS PROJECT - PHASE 2 LAGUNA BOULEVARD AT HARBOUR POINT DRIVE (WAC014 PHASE 2) AS COMPLETE; AUTHORIZING THE CITY ENGINEER TO PREPARE AND THE CITY CLERK TO FILE THE NOTICE OF COMPLETION WITH THE SACRAMENTO COUNTY RECORDER; AND AUTHORIZING STAFF TO AMEND THE ANNUAL BUDGET AND CAPITAL IMPROVEMENT PROGRAM BY REDUCING THE REMAINING PROJECT BUDGET AUTHORITY TO ZERO AND RETURNING ANY REMAINING FUNDS BACK TO THEIR RESPECTIVE FUND(S)

WHEREAS, on August 12, 2020, the City Council authorized the award of a construction contract to FBD Vanguard Construction, Inc., for the 2019-2020 Citywide Curb Ramp Improvements Project - Phase 2 Laguna Boulevard at Harbour Point Drive (WAC014 Phase 2); and

WHEREAS, the Project resulted in improved pedestrian access at the intersection of Harbour Point Drive and Laguna Boulevard for persons using wheelchairs or other personal assistance devices by reconstructing four curb ramps and upgraded pedestrian push buttons to an Accessible Pedestrian Pushbutton System that meets current ADA accessibility requirements (Work); and

WHEREAS, FBD Vanguard Construction, Inc. has completed the work in accordance with the terms and conditions of the contract documents for the Project; and

WHEREAS, if no liens or claims have been filed within 35 days of filing the Notice of Completion, the retained payment funds and any remaining amount due will be released to FBD Vanguard Construction, Inc.; and

WHEREAS, post construction work is typically completed within 120 days of the City Clerk filing the Notice of Completion with the Sacramento County Recorder and then all invoices can be paid.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby:


- 1) Accepts the 2019-2020 Citywide Curb Ramp Improvements Project - Phase 2 Laguna Boulevard at Harbour Point Drive (WAC014 Phase 2) as complete;
- 2) Authorizes the City Engineer to prepare a Notice of Completion and the City Clerk to file the Notice of Completion for the Project with the Sacramento County Recorder; and
- 3) Authorizes staff to amend the Annual Budget and Capital Improvement Program by reducing the remaining project budget authority to zero and returning any remaining funds back to their respective fund(s).
