**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE A MEMORANDUM OF
UNDERSTANDING WITH THE SACRAMENTO AREA COUNCIL OF
GOVERNMENTS (SACOG) FOR THE REGIONAL EARLY ACTION PLANNING
GRANT PROGRAM (REAP) IN THE AMOUNT OF \$140,000**

WHEREAS, SACOG has been awarded funds under Assembly Bill 101 (the Local Government Planning Support Grants Program) for the Regional Early Action Planning Grant Program (REAP); and

WHEREAS, pursuant to SACOG's REAP expenditure plan, the City will receive approximately \$140,000 in non-competitive funding to use toward activities that accelerate the production of housing; and

WHEREAS, in order to receive the \$140,000 in REAP funding, the City must enter into a Memorandum of Understanding with SACOG, which sets forth the terms of the use of funds.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk hereby:


- 1) Authorizes the City Manager to execute a Memorandum of Understanding with SACOG, in substantially the form presented, with the addition of a scope of work approved by the City Manager, and all subject to review and final approval as to legal form by the City Attorney, setting forth the terms of use for these REAP funds; and
- 2) Amends the Fiscal Year 2020-21 Budget by increasing both budgeted revenues and budgeted expenditures associated with professional services in the Affordable Housing Fund within the Development Services Department in the amount of \$140,000, or such other amount as may be awarded by SACOG.
