

**RESOLUTION NO. 2021-358**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
APPROVING THE ARTWORK PROPOSAL SELECTED BY THE REVIEW PANEL  
AND APPROVED BY THE ARTS COMMISSION FOR THE LAGUNA CREEK TRAIL  
MURAL AND AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT  
WITH THE ARTIST**

**WHEREAS**, the Elk Grove Arts Commission is dedicated to promoting arts and culture in the City and as part of their mission, the Commission has invested in public art throughout the community; and

**WHEREAS**, in 2020, the Commission expressed interest in creating a mural on the Laguna Creek Trail and requested staff to research the process; and

**WHEREAS**, the Arts Commission contacted the Trails Committee that was supportive of the idea and nominated a Committee member to serve on the Art Review Panel; and

**WHEREAS**, a Request for Proposals (RFP) was issued in March 2021. Three local artists responded to the RFP. A Review Panel consisting of two Commissioners and a Trails Committee member met on July 6, 2021, to review the proposals. The Panel recommended changes to one of the proposals and staff worked with the artist to implement the Panel's suggestions. The Review Panel reconvened on August 31, 2021, and approved the revised proposal; and

**WHEREAS**, the Arts Commission reviewed and approved the revised proposal at their meeting on September 16, 2021. The selected artist is an Elk Grove resident who has completed numerous murals for the Elk Grove Unified School District and other locations; and

**WHEREAS**, the Arts Commission allocated \$5,000 from their annual budget for the artist fee which includes supplies and labor for the mural.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby approves the artwork proposal selected by the Review Panel and approved by the Arts Commission for the Laguna Creek Trail Mural and authorizes the City Manager to execute a contract with the artist in substantially the form presented.
