

RESOLUTION NO. 2022-224

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO ACCEPT GRANT FUNDING FOR THE
SENATE BILL 1383 LOCAL ASSISTANCE GRANT PROGRAM THROUGH THE
STATE OF CALIFORNIA DEPARTMENT OF RESOURCES RECYCLING AND
RECOVERY (CALRECYCLE) AND TO AMEND THE RECYCLING AND WASTE
BUDGET TO APPROPRIATE GRANT FUNDS IN THE AMOUNT OF \$252,058**

WHEREAS Public Resources Code sections 48000 et seq. authorize the State of California Department of Resources Recycling and Recovery (CalRecycle) to administer various grant programs (grants) in furtherance of the state's efforts to reduce, recycle, and reuse solid waste generated in the state, thereby preserving landfill capacity, and protecting public health and safety and the environment; and

WHEREAS in furtherance of this authority, CalRecycle announced the availability of the Senate Bill 1383 (SB 1383) Local Assistance Grant Program intended to provide jurisdictions with a one-time grant to assist in implementing program requirements; and

WHEREAS the Recycling and Waste Division submitted a successful grant program application to implement many of the required programs to promote, educate and provide resources to residents to aid them in complying with SB 1383.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to:

- 1) Accept the SB 1383 Local Assistance Grant Program funding in the amount of \$252,058 from the Department of Resources Recycling and Recovery (CalRecycle); and
- 2) Amend the Recycling and Waste revenue and expense budget equal to the grant awarded, received, and expended each year until the total grant amount has been received and expended.
