**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY MANAGER TO EXECUTE A CREDIT REIMBURSEMENT  
AGREEMENT WITH REYNEN & BARDIS CONSTRUCTION, LLC,  
A CALIFORNIA LIMITED LIABILITY COMPANY FOR PRIVATELY CONSTRUCTED  
PUBLIC FACILITIES INCLUDED IN THE ELK GROVE ROADWAY FEE PROGRAM  
AND CONSTRUCTED FOR THE BENEFIT OF THE SOUZA DAIRY UNIT 5 PROJECT**

**WHEREAS**, Elk Grove Municipal Code Section 16.95.070 provides for reimbursement to developers for the private construction of any facilities designated in the Roadway Fee Program subject to entering into a reimbursement agreement with the City of Elk Grove (City); and

**WHEREAS**, Reynen & Bardis Construction, LLC, is constructing traffic light improvements on Big Horn Boulevard between Poppy Ridge Road and Kammerer Road, which is located in the City's Southeast Policy Area and identified in the Roadway Fee Program as eligible for reimbursement in the form of fee credits.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a Credit Reimbursement Agreements with Reynen & Bardis Construction, LLC in substantially the form presented, for reimbursement by way of credits against future fees from the Elk Grove Roadway Fee Program as follows:
