

**RESOLUTION NO. 2022-238**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY MANAGER TO APPROVE PARTICIPATION AS AN  
ADDITIONAL AGENCY BY EXECUTING THE ADDITIONAL AGENCY ADDENDUM  
TO THE MEMORANDUM OF UNDERSTANDING BETWEEN THE CITY OF  
SACRAMENTO, THE COUNTY OF SACRAMENTO, AND THE SACRAMENTO  
MUNICIPAL UTILITY DISTRICT REGARDING COORDINATION AND  
COOPERATION ON BUILDING ELECTRIFICATION EFFORTS**

**WHEREAS**, on May 17, 2022, the City received a letter from the Sacramento Environmental Commission recommending participation in a no-cost Memorandum of Understanding (MOU) recently adopted by the City and County of Sacramento and the Sacramento Municipal Utility District (SMUD); and

**WHEREAS**, the MOU establishes a process to coordinate and collaborate on new building and existing retrofit electrification projects, policies, and activities within participating jurisdictions; and

**WHEREAS**, the City is at risk of experiencing the devastating effects of extreme heat and weather events caused by rising atmospheric greenhouse gasses, resulting in climate change; and

**WHEREAS**, equitable building electrification represents a major GHG reduction for the County and will result in improved air quality and overall health; and

**WHEREAS**, participation in the MOU will lead to increased information sharing, avoid the duplication of work, provide for shared learning, help assure an equitable and just transition, and demonstrates to state and federal funding partners an existing, collaborative framework; and

**WHEREAS**, the building electrification MOU does not create any ordinance or regulation and does not commit or bind the City to any other jurisdiction's actions.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute the Additional Agency Addendum to the Memorandum of Understanding between the City of Sacramento, the County of Sacramento, and the Sacramento Municipal Utility District, in substantially the form presented, regarding coordination and cooperation on building electrification efforts.


