## **RESOLUTION NO. 2022-046**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER TO ACCEPT AN APPROPRIATION FROM THE STATE SUPPLEMENTAL LAW ENFORCEMENT SERVICES FUND IN THE AMOUNT OF \$272,879, APPROVING AN AMENDMENT TO THE POLICE DEPARTMENT'S REVENUE AND EXPENSE BUDGETS BY THAT SAME AMOUNT, AND AMENDING THE FISCAL YEAR 2021-22 POSITION LISTING

**WHEREAS**, the State Legislature has recently authorized the release of supplemental funding for frontline law enforcement under the State Supplemental Law Enforcement Services Fund (SLESF) for FY 2021-2022; and

**WHEREAS**, the amount appropriated for the Elk Grove Police Department is \$272,879; and

**WHEREAS**, funds under this program must be used in accordance with Government Code 30061 and approved by Resolution; and

**WHEREAS**, the Police Department has determined an expenditure plan that supports police operations and services for the City of Elk Grove; and

**WHEREAS**, the expenditure plan allocates funds to be used for one additional Communications Intelligence Specialist (CIS) position and one additional Police Equipment/Supply Technician (PT) position; and

**WHEREAS**, the CIS and PT positions will need to be covered by the other funding sources once SLESF funding has been fully expended.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby:

- 1) Authorizes the City Manager to accept an appropriation from the State Supplemental Law Enforcement Services Fund (SLESF) in the amount of \$272,879;
- 2) Approves an amendment to the Fiscal Year 2021-22 Police Department Budget, increasing the revenue and expense budget in the amount of \$272,879;
- 3) Directs the expenditure of funds in accordance with Government Code Section 30061; and
- 4) Amends the Fiscal Year 2021-22 Position Listing as follows:
