

RESOLUTION NO. 2022-093

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE APPROVING THE FY2022 THERMOPLASTIC RESTRIPING PROJECT (MP2203); AUTHORIZING THE CITY MANAGER TO EXECUTE A CONSTRUCTION CONTRACT WITH CENTERLINE STRIPING, INC. FOR THE FY2022 THERMOPLASTIC RESTRIPING PROJECT (MP2203) IN THE AMOUNT OF \$174,323.10; AUTHORIZING THE CITY ENGINEER TO APPROVE CHANGE ORDERS NOT-TO-EXCEED \$17,400; AND AUTHORIZING THE CITY MANAGER TO EXECUTE A CONSTRUCTION CONTRACT WITH THE SECOND LOWEST RESPONSIVE BIDDER IF THE FIRST LOWEST RESPONSIVE BIDDER DOES NOT MEET FILING OBLIGATIONS. (CEQA EXEMPT)

WHEREAS, the FY2022 Thermoplastic Restriping Project (MP2203) (Project) will result in restriping various streets throughout the City of Elk Grove with thermoplastic spray material as presented in the accompanying staff report; and

WHEREAS, an invitation to bid was duly advertised on March 11, 2022, and March 18, 2022, and electronic bids were received on April 5, 2022; and

WHEREAS, Centerline Striping, Inc. was determined to be the responsible bidder submitting the lowest responsive bid; and

WHEREAS, Central Striping Service, Inc. was determined to be the responsible bidder submitting the second lowest responsive bid; and

WHEREAS, the Project is a project under California Environmental Quality Act (Section 21000 et seq. of the Public Resources Code, hereinafter referred to as CEQA), which requires that cities consider the environmental consequences of their actions before approving a project.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby:

- 1) Finds the FY202 Thermoplastic Restriping Project (MP2230) exempt from the California Environmental Quality Act (CEQA) pursuant to Section 15301 (existing facilities) of the State CEQA Guidelines based upon the following finding:

Section 15301 (Existing Facilities) of the State CEQA Guidelines (Chapter 3 of Division 6 of Title 14 of the California Code of Regulations) provides an exemption from CEQA for projects involving the minor alteration of existing public or private facilities when the alteration involves negligible or no expansion of an existing use. As this Project involves restriping various streets throughout the City of Elk Grove with thermoplastic spray material and does not involve any expansion of use, it qualifies for the identified exemption and no additional environmental review under CEQA is required; and

- 2) Approves the Project; and
- 3) Authorizes the City Manager to execute a construction contract with Centerline Striping, Inc. for the FY2022 Thermoplastic Restriping Project (MP2203) in the amount of \$174,323.10 upon receipt of all required bonds and insurance and the approval of such bonds and insurance by the City Attorney; and


- 4) Authorizes the City Engineer to approve change orders not-to-exceed \$17,400; and
- 5) Authorizes the City Manager to execute a construction contract with the second lowest responsive bidder, Central Striping Service, Inc., if, Centerline Striping, Inc., does not meet filing obligations.
