

RESOLUTION NO. 2022-191

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
DISPENSING WITH THE FORMAL BIDDING PROCEDURE PURSUANT TO ELK
GROVE MUNICIPAL CODE 3.42.180(B)(3) AND AUTHORIZING THE CITY MANAGER
TO EXECUTE A THIRD AMENDMENT TO THE CONTRACT WITH GALLS, LLC
(CONTRACT #C-17-297) FOR BALLISTIC VESTS IN THE AMOUNT OF \$225,000 FOR
A TOTAL AMOUNT NOT-TO-EXCEED \$495,000 THROUGH JULY 31, 2025**

WHEREAS, each sworn and non-sworn field officer of the Elk Grove Police Department is issued a ballistic vest system, which is used to protect field personnel and is worn at all times when on duty; and

WHEREAS, Elk Grove Police Department replaces all ballistic vests for sworn and non-sworn officers as the vests near their five-year warranty expiration date; and

WHEREAS, in 2017, staff conducted a competitive bid process to find a vendor able to provide the ballistic vests at the best cost and within the timeframe outlined in a Request for Proposals (RFP) and awarded a contract to Galls, LLC (Galls); and

WHEREAS, Galls is the sole provider of Point Blank ballistic vest carriers and armor, the preferred ballistic vest system for EGPD based on proven dependability and consistency; and

WHEREAS, Galls is a local business that has demonstrated its ability to provide quality service and superior products at competitive pricing; and

WHEREAS, for the reasons presented, pursuing a formal competitive bidding process for ballistic vests is not in the best interest of the City.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby dispenses with the formal bidding procedure pursuant to EGMC 3.42.180(B)(3) and authorizes the City Manager to:

1. Execute a third amendment to contract #C-17-297 with Galls, LLC, for ballistic vests, in substantially the form presented, modifying pricing and increasing compensation by \$225,000, for a total amount not-to-exceed \$495,000 through July 31, 2025.
2. Execute all future amendments to the agreement concerning extensions of time and increases to pricing for products as allowed by the contract, provided that such amendments do not result in an increase to the total compensation paid to Galls, LLC.
