A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER TO EXECUTE AN ASSUMPTION AGREEMENT WITH INSURETRACK INSURETECH LLC (FORMERLY INSURANCE TRACKING SERVICES, INC.); DISPENSING WITH THE FORMAL REQUEST FOR PROPOSAL PROCEDURES PURSUANT TO ELK GROVE MUNICIPAL CODE SECTION 3.42.140(B)(3) AND AUTHORIZING THE CITY MANAGER TO EXECUTE THE THIRD AMENDMENT TO THE CONTRACT WITH INSURETRACK INSURETECH LLC, FOR INSURANCE CERTIFICATE TRACKING SERVICES, EXTENDING THE TERM FOR A PERIOD OF ONE YEAR AND ADDING \$10,000 [FOR A TOTAL EXPENDITURE OF FUNDS OVER THE CONTRACT TERM NOT-TO-EXCEED \$105,000]

- **WHEREAS**, the City of Elk Grove (City) utilizes consultants to perform insurance certificate tracking services; and
- **WHEREAS**, in November 2017, the City entered into a contract with Insurance Tracking Services, Inc., for insurance certificate tracking services (C-17-644), as amended by C-18-649 and C-19-464; and
- **WHEREAS**, Insurance Tracking Services, Inc., re-formed as InsureTrack InsureTech LLC, a Delaware limited liability corporation in October of 2021; and,
- **WHEREAS**, InsureTrack InsureTech LLC, provides unique functions within its services which significantly reduce the staff time spent administering insurance certificates; and
- **WHEREAS**, the existing contract for these services will expire October 31, 2022; and
- **WHEREAS**, staff has determined that a formal request for proposal procedure for the proposed services will not yield results more advantageous to the City; and
- **WHEREAS**, for the reasons presented, pursuing a formal request for proposal process for the proposed services is not in the best interest of the City.
- **NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby:
- 1. Authorizes the City Manager to execute an Assumption Agreement, in substantially the form presented, recognizing the assumption of services originally contracted with Insurance Tracking Services, Inc., by InsureTrack InsureTech LLC;
- 2. Dispenses with the formal request for proposal procedure pursuant to Elk Grove Municipal Code Section 3.42.140(B)(3) and authorizes the City Manager to execute the Third Amendment to the contract with InsureTrack InsureTech LLC, in substantially the form presented, for insurance certificate tracking services, extending the term for a period of one year and adding \$10,000 [for a total expenditure of funds over the contract term not-to-exceed \$105,000].
