

RESOLUTION NO. 2022-309

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT WITH ELK
GROVE HOMELESS ASSISTANCE RESOURCE TEAM (HART) FOR VARIOUS
SERVICES TO PEOPLE EXPERIENCING HOMELESSNESS OR AT RISK OF
HOMELESSNESS**

WHEREAS, on March 11, 2021, the American Rescue Plan Act of 2021 (ARPA) was signed into law and is intended to combat the public health and economic impacts of the COVID-19 pandemic; and

WHEREAS, the City received a total of \$21,944,605 in ARPA funding over two years to respond to the COVID-19 public health emergency and its economic impacts; and

WHEREAS, the City Council approved an ARPA Expenditure Allocation Plan that included \$2,000,000 for “flexible homeless solutions;” and

WHEREAS, low-income households are presumed under ARPA guidance to be negatively impacted by COVID-19; and

WHEREAS, the Elk Grove Homeless Assistance Resource Team (“Elk Grove HART”), a longtime partner of the City in addressing homelessness, is a nonprofit organization eligible to receive a subgrant of ARPA funding; and

WHEREAS, Elk Grove HART requested a total of \$70,000 to serve people experiencing homelessness or at risk of homelessness with a combination of programs, including motel vouchers, application fee assistance, and eviction prevention; and

WHEREAS, such uses are eligible uses of ARPA funding.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a Subrecipient Agreement with Elk Grove HART, a public benefit nonprofit corporation, in substantially the form presented, providing for funding of programs to benefit people experiencing homelessness or at risk of homelessness.
