

**RESOLUTION NO. 2023-118**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE DISPENSING WITH THE FORMAL REQUEST FOR PROPOSAL PROCEDURE PURSUANT TO ELK GROVE MUNICIPAL CODE SECTION 3.42.188(B)(3), AND AUTHORIZING THE CITY MANAGER TO EXECUTE THE SIXTH AMENDMENT WITH SUPERION, LLC FOR CITYWIDE SOFTWARE PRODUCTS AND SERVICES, FOR A TERM OF THREE YEARS IN AN AMOUNT NOT TO EXCEED \$1,232,545.75 FOR A TOTAL COMPENSATION AMOUNT NOT TO EXCEED \$9,033,882.75**

**WHEREAS**, in 2003 the City issued a formal Request for Proposal for the purchase of Citywide software and Superion, LLC (Central Square Technologies) was awarded Contract No. C-03-145; and

**WHEREAS**, the City has used this software for 19 years as its Citywide software program to house centralized data that is accessed by over 300 staff members from every department; and

**WHEREAS**, the City completed a review of the system in 2022 and determined that best practices are being met and the current software meets the needs of staff; and

**WHEREAS**, the three-year extension will allow the continuity of business; and

**WHEREAS**, costs for this extension have been included in the Information Services budget for FY 2023-24, and costs for future years will be included in the respective fiscal years' budgets; and

**WHEREAS**, for the reasons presented, a formal request for proposal procedure for the subject services is not in the best interest of the City.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby dispenses with the formal request for proposal procedure pursuant to Elk Grove Municipal Code Section 3.42.188(B)(3) and authorizes the City Manager to execute the sixth amendment to the contract with Superion, LLC, for Citywide software and services, in substantially the form presented, for a term of three years in an amount not to exceed \$1,232,545.75, for a total compensation amount not to exceed \$9,033,882.75.
