

RESOLUTION NO. 2023-231

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
TO ABANDON PROCEEDINGS OF ANNEXATION NO. 71 TO COMMUNITY
FACILITIES DISTRICT NO. 2003-2 (POLICE SERVICES)**

WHEREAS, on November 5, 2003, the City Council (the "City Council") of the City of Elk Grove (the "City"), approved Resolution No. 2003-214 establishing Community Facilities District No. 2003-2 (Police Services) (the "CFD") pursuant to the Mello-Roos Community Facilities Act of 1982, as amended (the "Act"), being Chapter 2.5, Part 1, Division 2, Title 5 of the Government Code of the State of California, for the purpose of providing for the financing of certain police protection services; and

WHEREAS, on August 9, 2023, the City Council adopted Resolution No. 2023-179 to annex territory into CFD 2003-2 (Police Services); and

WHEREAS, City staff has determined that Annexation No. 71 of Community Facilities District No. 2003-2 (Police Services) is not recommended at this time for this project and that the project can annex under a new annexation at a future date prior to building permit issuance; therefore, staff recommends that the proceedings to complete the above annexation be abandoned by the City Council. The certificate of the City Clerk providing notice of the abandonment is attached as Exhibit A and incorporated by reference.

NOW, THEREFORE BE IT RESOLVED by the City Council of the City of Elk Grove as follows:

Section 1. Abandonment of Proceedings. Based upon the foregoing, the City Council hereby orders that all proceedings of Annexation No. 71 of Community Facilities District No. 2003-2 (Police Services) be abandoned.

Section 2. Recording of Notice. The City Clerk is hereby directed to record, with the Sacramento County Recorder's Office, a certified copy of this Resolution of Abandonment pursuant to Section 3117 of the California Street and Highways Code.

Section 3. Effective Date. This Resolution shall take effect immediately upon its passage.




