

RESOLUTION NO. 2024-006

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT WITH
AVI-SPL LLC FOR A BARCO VIDEO WALL IN AN AMOUNT
NOT TO EXCEED \$342,616.19**

WHEREAS, the Elk Grove Police Department's Real-Time Information Center (RTIC) has used a video wall as a primary viewing platform during critical incidents, calls for service, and disasters in the City of Elk Grove since its inception in 2019; and

WHEREAS, the current video wall is no longer supported by the manufacturer and is unable to be repaired when video wall monitors break; and

WHEREAS, maintaining a reliable video wall is crucial for efficient operations during critical events and/or disasters in Elk Grove; and

WHEREAS, staff conducted a formal request for proposal process seeking service providers to submit proposals for a Barco video wall that would offer the City of Elk Grove competitive pricing and quality service; and

WHEREAS, staff evaluated six proposals received and determined AVI-SPL LLC was able to provide the product and services requested in the RFP at the most competitive pricing.


